**RELEASE OF LIABILITY, CONDUCT AGREEMENT, and PHOTO/VIDEO RELEASE**

This is a legally binding Release, Waiver, Discharge and Covenant Not to Sue (collectively, "Release"), made voluntarily by me, the undersigned Releasor, on my own behalf, and on behalf of my heirs, executors, administrators, legal representatives and assigns (hereinafter collectively, "Releasor," "I" or "me" to SkydiveRatings.com LLC.

As the undersigned Releasor, I fully recognize that there are dangers and risks to which I may be exposed by participating in SkydiveRatings.com LLC 's Activities (the "Activity" including but not limited to skydiving, tandem skydiving, ground instruction, in-air instruction, parachute instruction, riding in aircraft at any phase of operation, aircraft exit, freefall, deployment of parachute, time under parachute, landing, rescue operations or attempts, demonstration jumps, water jumps, ground or air transportation or transportation in any vehicle, use of equipment, wind tunnel training, or any activity whatsoever.

As the undersigned Releasor, I understand that SkydiveRatings.com LLC does not require me to participate in this Activity, but I choose to do so despite the possible dangers and risks and despite this Release. With informed consent, and for valuable consideration received, including training and/or assistance provided by SkydiveRatings.com LLC, as the undersigned Releasor, I agree to assume and take on myself all of the risks and responsibilities in any way arising from or associated with this Activity, and I release SkydiveRatings.com LLC and all of its affiliates, owners, employees, volunteers, agents, assigns, and contractors (collectively "Releasees"), from any and all claims, demands, suits, judgments, damages, actions and liabilities of every name and nature whatsoever, whenever occurring, whether known or unknown, contingent or fixed, at law or in equity, that I may suffer at any time arising from or in connection with the Activity, including any injury or harm to me, my death, or damage to property (collectively "Liabilities"), and I agree to defend, indemnify, and save Releasees harmless from and against any and all Liabilities.

I agree that this Release shall be governed for all purposes by Florida law, without regard to such law on choice of law. I have read this entire Release. I fully understand the entire Release and acknowledge that I have had the opportunity to review this Release with an attorney of my choosing if I so desire, and I agree to be legally bound by the Release.
